# CONDITIONS

## IMPORTANT - READ CAREFULLY

**STALLS ASSIGNED UNDER THE FOLLOWING CONDITIONS: YOUR SIGNATURE ON THE REVERSE SIDE INDICATES THAT YOU AGREE TO BE SUBJECT TO THE FOLLOWING CONDITIONS, RULES, ETC.**

- 1 The granting of stalls pursuant to this application in whole or in part shall not constitute a lease of space but a revocable license only.
- 2 **I AGREE** that any and all substitutions for the horses named on the stall application and all changes of the conditions of the same, must be approved in writing by Evergreen Park prior to date of shipping. The horses named on the stall application and all substitutions approved as aforesaid shall be hereinafter called "the horses".
- 3 **I AGREE** that as and when from time to time, any of the horses that are dropped from training or are not to be raced at the Meet in progress I will immediately inform Evergreen Park in writing giving the names of such horses.
- 4 **Evergreen Park** shall not be liable for injury or loss suffered in any manner to me, any personnel employed by me, to a horse or horses belonging to me or to those for whom I am an agent or trainer, while on the premises, whether caused by condition on the premises or otherwise.
- 5 **I AGREE** to indemnify and hold Evergreen Park, its officers, employees and agents, harmless against any and all claims, liabilities, losses, costs, damages and attorney fees incurred by reason of the conduct of negligence of the undersigned or of his agents or employees, but this indemnity shall not extend liabilities, claims, losses, damages, or attorney fees arising out of the negligence or willful acts or omissions of Evergreen Park or their respective agents or employees.
- 6 **I AGREE** to abide by and be governed by the lawful rules of Horse Racing Alberta.
- 7 **I AGREE** that this contract is made with and shall ensure to the benefit of Evergreen Park.
- 8 **I AGREE** to remove my horses and/or those in my possession charge or control together with all personal property belonging to me, or of which I have possession, charge or control from the grounds of Evergreen Park forthwith upon the expiration of twenty-four (24) hours after Evergreen Park had given me notice in writing to vacate the stabling accommodation. Notice may be given for reasonable cause with said reason or cause being stated or given. Any such notice or another notice given hereunder shall be sufficiently given by posting up such notice on some portion of the stabling accommodations allotted to me, such notice shall be deemed to be given at the time when the same is posted up. I understand that my employees shall leave Evergreen Park upon the expiration of twenty-four (24) hours notice herein before mentioned. Any horses or personal property belonging to me or in my possession, charge or control, have not been removed from the said Evergreen Park premises, shall be entitled to remove the same from the said premises without further notice, either to a public pound, or Evergreen Park may stable the same at my expense elsewhere. Evergreen Park shall in no event, either jointly or severally be responsible for any such horse or horses removed as aforesaid.
- 9 **I AGREE** that in the event of the horses being stabled elsewhere at my expenses aforesaid that the person, firm or corporation stabling the horses or paying for the stabling of the same shall have all rights of the keeper of a boarding stable under The Livery Stable Keepers Act.
- 10 It is understood that Evergreen Park reserves the right at anytime to deny access to Evergreen Park premises to me, my employees, to my agents, to any persons under my control or any person firm or corporation contracting with me.
- 11 **I AGREE** that I will not damage the stabling accommodation allotted to me. I will not make or permit any structural changes in the said stabling accommodation; **that I will also be responsible for all costs to repair damages to the stabling accommodation allotted to me while the horses or any of them are stabled therein**; that I will keep such stabling accommodation in good and clean condition and deposit the manure and litter where directed by Evergreen Park. Shavings and peat moss for bedding only.
- 12 **I AGREE** that there is no representation, warranty, or collateral agreement given or made by Evergreen Park office affecting this agreement other than expressed here in writing.
- 13 **ABSOLUTELY NO DOGS IN THE BARN AREA.**
- 14 **TRAILERS/R.V.'s: Please register immediately with the Campground Office.** A valid camping permit must be visible at all times on your unit. Location of camping is at the discretion of Evergreen Park.
- 15 **The use of tents is prohibited, except in the main campground.**
- 16 **The use of tack rooms for residence or sleeping purposes is prohibited.**
- 17 All vehicles and trailers including horse trailers will be parked where directed. This includes ship-ins.
- 18 **I AGREE** with the responsibility of the costs or removal of dead horses.
- 19 Walker space to be allotted by Racing Manager. **Do not set up walkers without permission.**
- 20 No electrical wiring, heating or lighting apparatus shall be installed in the stall accommodation allotted hereunder, or in any other facilities on the Grounds, without the prior written approval of Evergreen Park.
- 21 All exits, electrical rooms, fire pull stations, and extinguishers must be kept free of materials, equipment, accumulations of waste or other obstructions that might endanger workers or restrict their movement to the exits. Any of the above mentioned that is found to be blocking the entrances or exits to the work areas will be removed and will be returned at the discretion of Evergreen Park, at a charge of \$75/hour.

**NOTE: It should be remembered that demand is likely to exceed available stall space, therefore, limitation of space may require Evergreen Park to turn down all or part stabling request.**
